# **COMPLIANCE WITH POSITIVE IMPACT PLAN**Progress or Success Goal 1

Description of Progress or Success: NETA's first stated goal of its Positive Impact plan is to provide access to employment opportunities in the cannabis industry for residents in areas of disproportionate impact as defined by the Commission. To make progress toward this goal, NETA has focused on targeted recruiting efforts and job fair and event participation, including the Equity and Opportunity Jobs Fair and CORI Sealing Clinic, the Rebuild Boston Community Conference & Career Fair and the 2018 and 2019 Roxbury Community College & Fenway CDC Career Fairs. To date, NETA has accomplished a rate of 18% of employees residing in areas of disproportionate impact. NETA continues to track this information for its employee pool and will set annual goals to increase representation from these disproportionately impacted areas, and will continue to target recruitment efforts accordingly.

#### Progress or Success Goal 2

Description of Progress or Success: NETA's second stated goal of its Positive Impact plan is to provide mentoring, professional development, and experience in the cannabis industry to individuals disproportionately affected by the drug war and to those residing in areas of disproportionate impact.

NETA's progress toward this goal includes the launch of an internship program in partnership with Roxbury Community College ("RCC") whereby students matriculating in a business program at RCC may apply for and receive compensated, for-credit internships in NETA's cultivation, product manufacturing and retail locations. Training for those enrolled in this program will be focused on, but not limited to: Human Resources, Cultivation, General Business, and Dispensary Operations. These internships are designed to give immersive educational and practical experiences in a thriving, vertically integrated Massachusetts marijuana establishment. To date, two students from RCC have participated in this program with specific focus on Cultivation and Information Technology operations. NETA is currently working with RCC to promote the program further and bring in more candidates for the future semesters. NETA will take up to 3 interns in this program per semester.

Also toward this goal, NETA partnered with the Cannabis Community Care and Research Network (C3RN) to develop a diversity scholarship program to financially support students and persons otherwise unable to afford the ticket price for C3RN's 2018 Cannabis Science, Education, and Networking Series. By subsidizing the cost of attendance, NETA provided opportunities for students matriculating in areas of disproportionate impact to participate in C3RN's sixmonth (Jan – Jun 2018) cannabis science, education, and networking series that was designed to bring key clinical, academic, and cannabis communities together. Scholarships were issued to students from areas of disproportionate impact including from Roxbury Community College, Holyoke Community College, and North Essex Community College in Lawrence.

For the upcoming year, NETA is also working on formalizing a mentoring program for the professional development of Certified Economic Empowerment status holders and Social Equity Program participants across the state. The goal is to ensure a sufficient pool of social equity program participants are ready for the rigors and successes they will encounter in the cannabis industry. Internally, members of NETA's leadership who serve as mentors will gain new perspective and insight as a result of the mentor relationship and will be able to share their expertise with the mentee. The program is in its development stage and will be included as part of NETA's 2020 Positive Impact Plan.

#### Progress or Success Goal 3

Description of Progress or Success: NETA's third stated goal of its Positive Impact plan is to provide guidance, information and tours for individuals and groups who fall under the Commission's social equity mandate

In an effort to assist these applicants through the ME licensing process, NETA has provided tours of it's licensed cultivation, product manufacturing and retail marijuana establishment facilities and has provided guidance and information about the licensing process and marijuana establishment operations. To date, NETA has provided such tours and coaching to Enid Pope, a certified Economic Empowerment applicant and to Lamont Scott, an ME applicant from Springfield, an area of disproportionate impact, who was negatively impacted by the war on drugs. Several members of the NETA team have offered time and assistance to these individuals to improve their chances of success in this industry. Moving forward, NETA intends to broaden its outreach and provide more even mentoring opportunities through targeted outreach by our Director of Diversity Programs and through the formalization of a NETA mentoring program, which is in development and described in the previous response.

To encourage the participation and advancement of people and groups that fall within the Commission's Social Justice mandates, NETA supported C3RN"s application to be accepted as an equity training vendor, with their partners the City of Holyoke and Holyoke Community College. C3RN is developing a robust, multi-disciplinary cannabis-focused education, internship, mentorship, and job placement network to support expanding a skilled new workforce for the cannabis industry. NETA committed to acting as a partner in the C3RN and Holyoke workforce training program as a site for student internships, apprenticeships, educational leadership and/ or other training inputs.

In an effort to expand access to information and knowledge to those disproportionately impacted by the drug war, NETA's Director of Diversity Initiatives also participates regularly in forums, panels and events that aim to provide guidance, expertise and nuanced information about the cannabis industry and licensing process and with a focus on social equity, diversity and inclusion. These events provide useful and practical opportunities for individuals and groups to bolster their chances of success in the cannabis industry. Our Director of Diversity Programs has recently participated in equity-centric events including but not limited to: The Boston Globe's Engineering Equity Panel at Boston NECANN 2019, The Civic Series' Cannabis 101: Molecules, Markets, ...Mayhem?, and WGBH's Basic Black program "Marijuana in Massachusetts & How People of Color Fit In".

# **COMPLIANCE WITH DIVERSITY PLAN**Diversity Progress or Success 1

Description of Progress or Success: NETA's first stated goal of its Diversity Plan is to continue to increase the representation of women and minorities at NETA. Progress toward this goal is accomplished through targeted recruiting efforts, leadership development training, and prioritizing internal promotions within the organization. NETA strives to bring in diverse applicants through its recruitment process, and with a focus on professional development internally, many of these hired candidates are provided opportunities to advance within the organization.

NETA tracks the diversity demographics of its workforce through its EEO-1 annual filing. NETA's reporting has demonstrated year over year improvements in the diversity of its workforce. Specifically:

- -NETA has reduced male representation at NETA by just over 3%, despite have increased our workforce by more than 200 since our last data set.
- -NETA has increased representation among black employees by just over 3%, nearly doubling the employee base of black men in the NETA workforce since our last data set.
- -NETA employs fewer males (percentage wise) than the pending and approved agent registration count at the CCC (As of 4/25/19).
- -NETA employs nearly twice as many black employees than the pending and approved agent registration count at the CCC (As of 4/25/19).
- -With the exception of white employees, NETA is more diverse than the pending and approved agent registrations on file at the CCC as of their 4/25/19 meeting (which is the most recent data set available).

#### **Diversity Progress or Success 2**

Description of Progress or Success: NETA's second stated goal of its Diversity Plan is to better understand the available pool of diverse talent for NETA open positions and internal advancement opportunities. To this end, NETA has commissioned Ogletree, Deakins, Nash, Smoak & Stewart, P.C. to perform an Availability Analysis, which is currently underway. The Availability Analysis will allow NETA to better understand the availability of qualified diverse candidates and where NETA can target its recruitment efforts to continue its goals of maintaining a diverse and vibrant workforce. NETA expects to receive a report of this analysis in the coming weeks, which will help to shape its recruitment efforts and its 2020 Diversity Plan.

#### **Diversity Progress or Success 3**

Description of Progress or Success: NETA's third stated goal of its Diversity Plan is to create a work environment that leverages diversity and inclusion in the achievement of business results. Toward this goal, NETA commissioned Ogletree, Deakins, Nash, Smoak & Stewart, P.C. to design and deliver diversity training to NETA's supervisors and management teams. This training includes topics such as Unconscious Bias, Generational Differences, Cultural Communication, Inclusion, Micro-messaging/Microinequities, Bridging Communication Barriers and Harassment. Diversity trainings at NETA are not only helping our employees to understand the importance of diversity, but to also to educate employees on what diversity and inclusive thinking means in their day-to-day interactions with co-workers, patients, customers and others. NETA's Director of Diversity Programs, along with NETA's HR and training teams, will continue to deliver diversity trainings as designed and updated by Ogletree Deakins on an ongoing basis to continue to foster a diverse and inclusive work environment that supports NETA's overall success as an organization.

To promote and support diversity and inclusivity in its operations, NETA ensures that its communications materials, including website (www.netacare.org), handbooks, and other materials are culturally sensitive and highlight and promote diversity within NETA's workforce, as well as it's patient and customer base and the communities NETA serves.

Externally, NETA supports the inclusion and development of skills for differently abled adults through a partnership with the MUSE Foundation, a local Brookline 501c3. MUSE stands for Music, Unity, and Social Expansion and focuses on creating community-based support systems and relationships through music. Through its partnership with NETA, MUSE has been able to expand its needs-based scholarship students and have a bigger impact in the community.
