### Demographics of Approved and Pending Agents

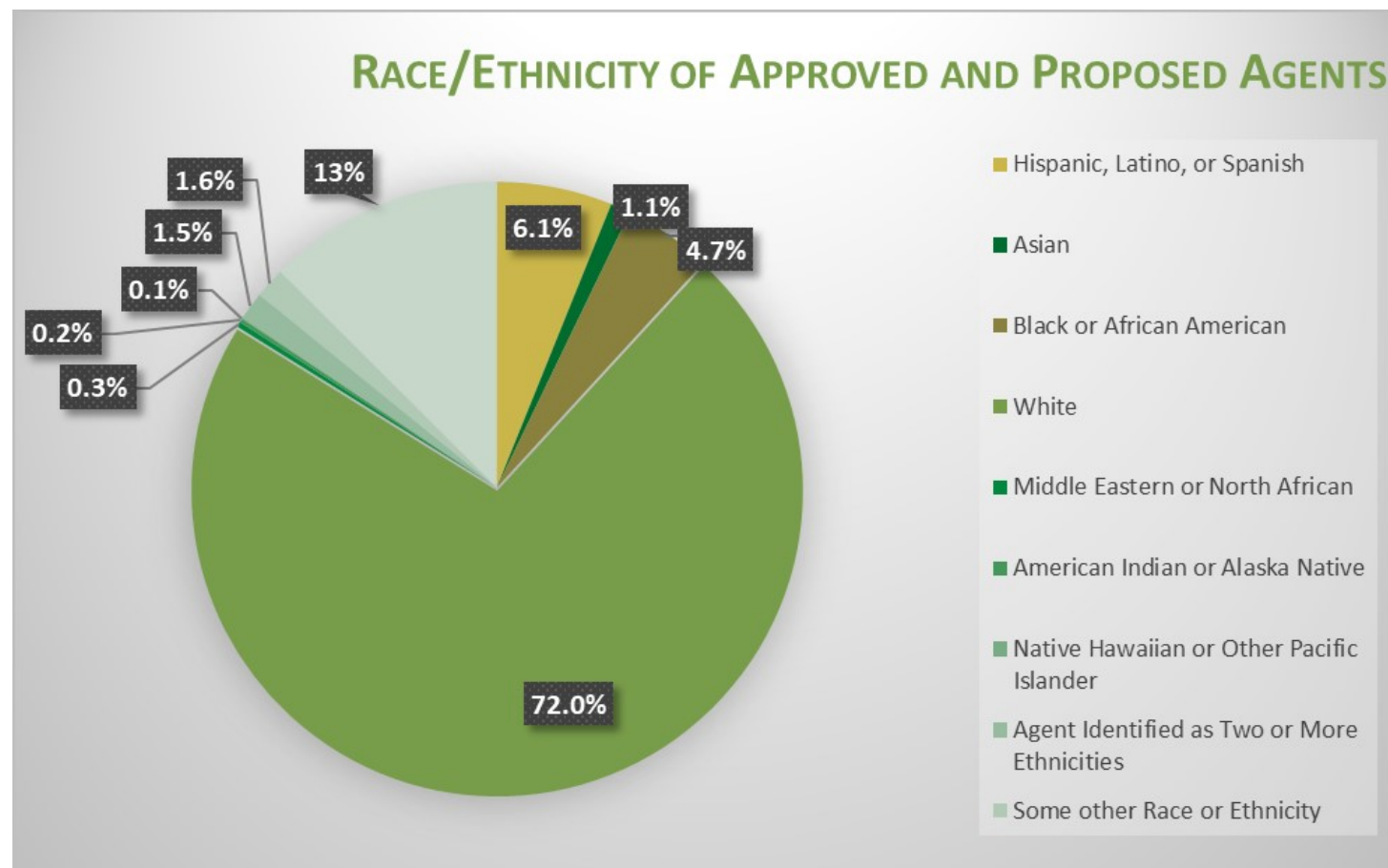

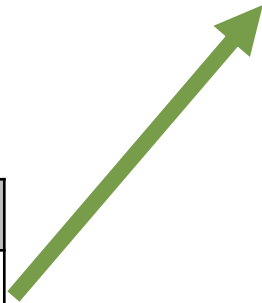

## **Equity Work Plan**

- Contract with a research institution on a robust study of barriers to entry and meaningful participation, including an examination of why certified economic empowerment applicants haven't applied.
  - ✓ *The Commission is in the process of preparing a procurement, utilizing an existing statewide contract, to identify a research partner. This project will be led by our Director of Research, Dr. Julie Johnson.*
- Review the geographic diversity of Social Equity Program applicants throughout the Commonwealth and adjust outreach accordingly.
  - ✓ *The Commission, as it reviews applications for the Social Equity Program, is identifying regions of the Commonwealth that are underrepresented by applications and will begin planning and advertising outreach events accordingly. This project will be led by our Director of Community Outreach, Shekia Scott.*

## Equity Work Plan

- Collect data on ancillary businesses, including vendors used by Commission licensees, and include it in all reports on participation in the industry.
  - ❑ *The Commission will develop an RFP process to assist the Research Department in developing an on-going study to assess ancillary businesses in the cannabis industry with contractual collaboration with researchers with expertise in business and economics. This project will be led by our Director of Research, Dr. Julie Johnson.*
- Create regulations allowing shared-use cultivation and shared-use manufacturing space for certain groups of applicants or licensees, to address the barriers to entry poised by securing real estate, facility design, and local approval processes.
  - ❑ *The Commission has begun research regarding different analogous models, including tenant brewer licenses in the Commonwealth, and Type S cannabis licenses in California, in order to develop policy recommendations. Given the current schedule for regulatory changes, staff will complete its research and as appropriate, propose recommendations for the Fall 2019.*

## Equity Work Plan

- Consider whether the Commission has the authority to revisit existing priority status and create new priority status(es) based on the Commission's mission statement and current data examining participation in the legal marijuana industry in Massachusetts.
  - ✓ *Commission staff has conducted a legal analysis regarding the ability to revisit or initiate a new priority status. This evaluation has been shared with the Commission.*
- Create a single-packet or abbreviated application process for economic empowerment applicants and equity program participants that takes place before the local approval process, specifically before the negotiation of a host community agreement.
  - ❑ *The Commission has explored the ability to consider certain elements of a complete marijuana establishment application, including background check and business plans, and conduct a preliminary evaluation. This would entail developing a new, separate application for Pre-Approval, which would ultimately require Commission consideration and approval. Given the current schedule for regulatory changes, staff will propose recommendations for the Fall 2019.*

## Equity Work Plan

- Issue formal recommendations to the Legislature addressing the creation of grant programs or interest-free loan programs for equity program participants.
  - ❑ *The Commission, through the Chairman, has begun to evaluate various models for such a program and pursue strategies relative to identifying sources of funds as well as program requirements. This project has been led by Chairman Hoffman.*
- Consider requiring retailers to source a certain amount or percentage of products from equity program participants or microbusinesses or craft co-ops.
  - ❑ *The Commission will evaluate the legality of such a requirement, as well as other, similar models, including Colombia. This project will be led by our legal staff.*



## Equity Work Plan

- Devote a small amount of staff time and resources to facilitating conversations among regulators in jurisdictions with cannabis equity programs, focusing on topics including but not limited to:
  - Consistent data collection
  - Best practices for developing curricula and selecting technical assistance providers
  - Preventing predatory practices aimed at equity program participants
  - Working with the state's existing certification and resources for disadvantaged business enterprises
- ✓ *The Commission has long enjoyed productive dialogue with other jurisdictions, and will continue to explore opportunities for collaboration. In specific reaction to equity programs, the Commission will expand these efforts to include municipal interactions within the Commonwealth, as well as across the country. This project is shared amongst staff, but specifically includes the Director of Community Outreach, Shekia Scott, Commissioners, and the Executive Director.*

## Equity Work Plan

- Issue recommendations to, or collaborate directly with, the Legislature regarding community trusts or other models for affordable commercial space for small businesses sharing space and costs.
  - ❑ *The Commission will research the viability of a community trust or other similar model for shared space and return with recommendations for the Commission's consideration. This project will be shared by the Commission's legal and government affairs staff.*
- Consider re-evaluating the income limit for equity program participants.
  - ✓ *The Commission ought to reconsider any income threshold for the Social Equity Program, and may consider other modifications or updates during the upcoming regulatory review. This project will be led by our legal staff, in consultation with our Director of Community Outreach.*

## **Equity Work Plan**

- Engage with licensees on progress toward their diversity plans and positive impact plans before renewal, perhaps quarterly.
  - ❑ *The Commission, given the data available through MassCIP and now leveraged through the open data platform, can provide licensees with periodic updates (ex. 6 months) regarding the demographics of their agent registrations. Similarly, investigators will plan to inquire during routine inspections regarding the progress of positive impact plans. This project will be led by our investigative team.*
- Provide more detailed information and data about compliance on the Commission website, with the goal to minimize the need to hire consultants to interpret regulations and requirements.
  - ❑ *The Commission will continue to evaluate the design and layout of our website, especially for ease of navigation and accessibility of content. With the transfer of the medical use of marijuana program, as well as the introduction of an open data platform, the Commission ought to consider a comprehensive review of all materials. This project will be led by our Communications Department.*

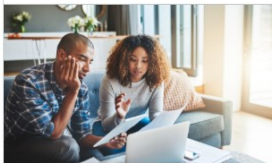

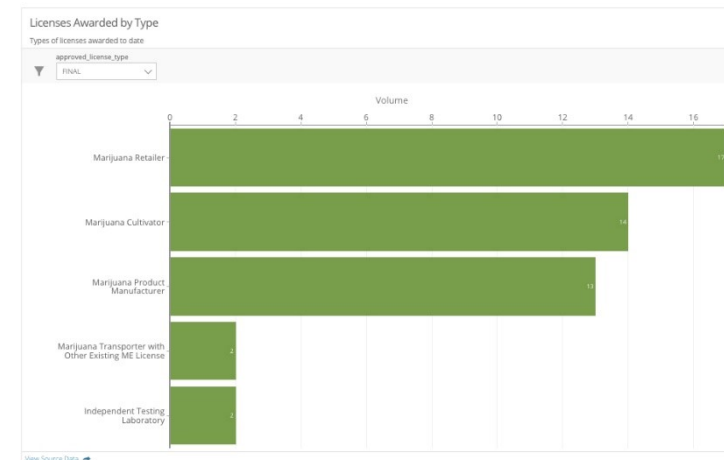
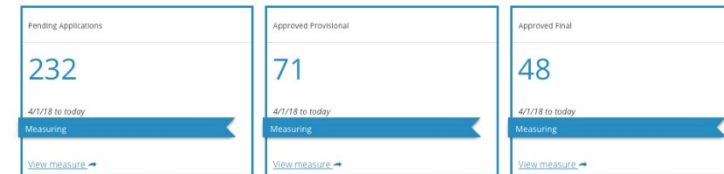
## Applications and Licensing

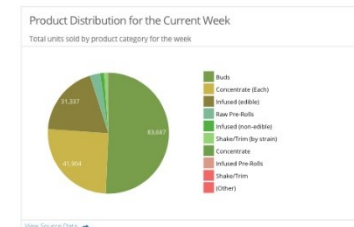
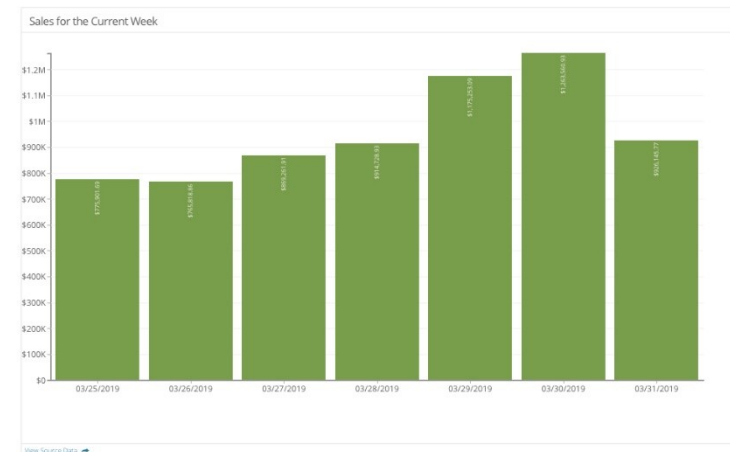
**Pending Application:** an application in which all four packets have been submitted and is pending a completeness review.

**Provisional License:** a certificate that confirms a Marijuana Establishment has completed the application process.

**Final License:** a certificate that demonstrates a Marijuana Establishment is in compliance with applicable laws and regulations.

# Chapter 55: An Act to Ensure Safe Access to Marijuana

**Section 17. (a) The commission shall develop a research agenda in order to understand the social and economic trends of marijuana in the commonwealth, to inform future decisions that would aid in the closure of the illicit marketplace and to inform the commission on the public health impacts of marijuana. The research agenda shall include, but not be limited to:**

- (i) patterns of use, methods of consumption, sources of purchase and general perceptions of marijuana among minors, among college and university students and among adults;
- (ii) incidents of impaired driving, hospitalization and use of other health care services related to marijuana use, including a report of the state of the science around identifying a quantifiable level of marijuana-induced impairment of motor vehicle operation and a report on the financial impacts on the state healthcare system of hospitalizations related to marijuana;
- (iii) economic and fiscal impacts for state and local governments including the impact of legalization on the production and distribution of marijuana in the illicit market and the costs and benefits to state and local revenue;
- (iv) ownership and employment trends in the marijuana industry examining participation by racial, ethnic and socioeconomic subgroups, including identification of barriers to participation in the industry;
- (v) a market analysis examining the expansion or contraction of the illicit marketplace and the expansion or contraction of the legal marketplace, including estimates and comparisons of pricing and product availability in both markets;
- (vi) a compilation of data on the number of incidents of discipline in schools, including suspensions or expulsions, resulting from marijuana use or possession of marijuana or marijuana products; and
- (vii) a compilation of data on the number of civil penalties, arrests, prosecutions, incarcerations and sanctions imposed for violations of chapter 94C for possession, distribution or trafficking of marijuana or marijuana products, including the age, race, gender, country of origin, state geographic region and average sanctions of the persons charged.

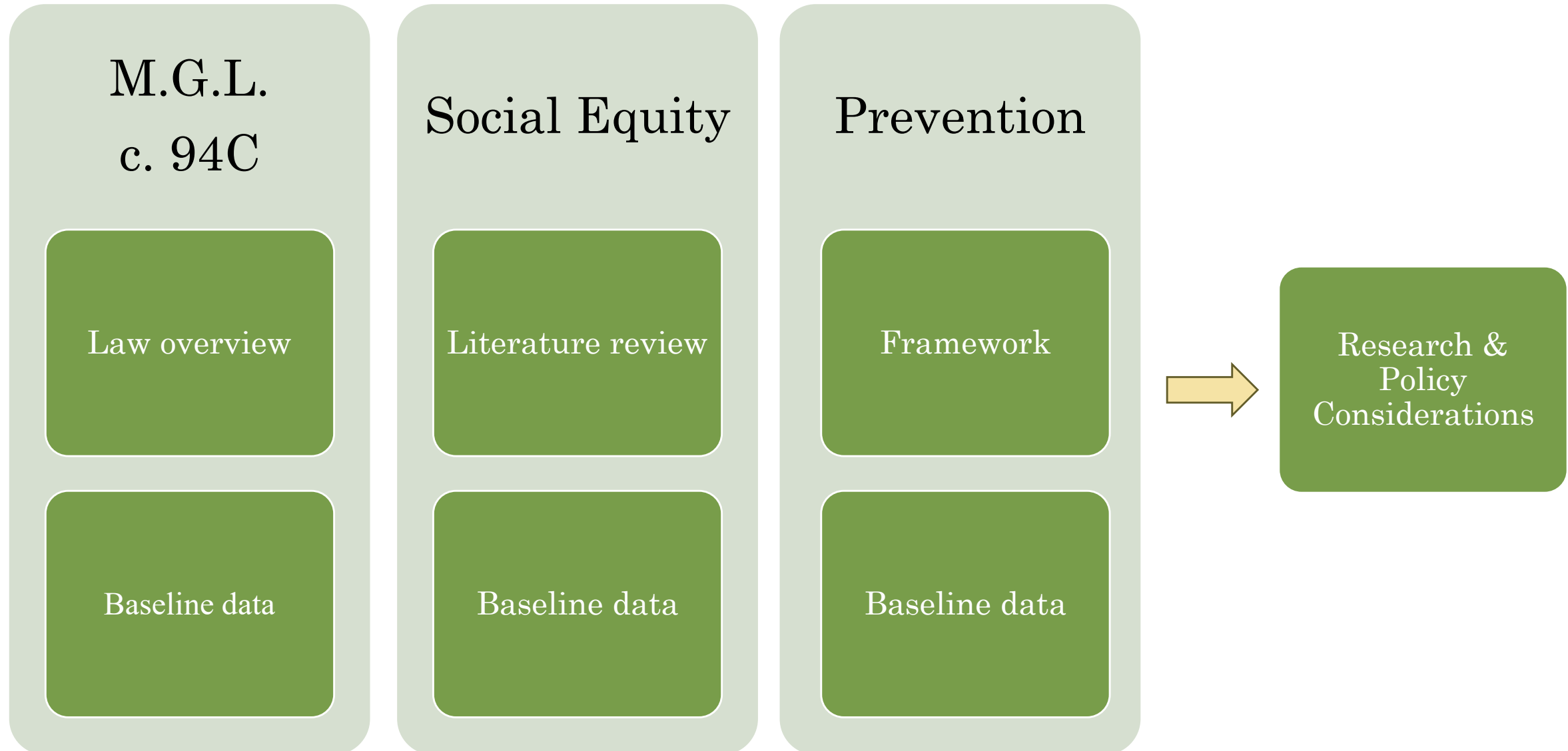

# Statistical Considerations

- **Rates (frequencies and percents) were examined; However, no statistical tests of significance were conducted due to statistical weighing concerns and resources needed.**
- **Differing dataset measures are not comparable across datasets (*e.g. Measures for “Trafficking,” and Race/Ethnicity, “Marijuana vs. Class D” differ across datasets*)**

# How have 94C violations changed over time? (“baseline”)

- Possession violations decreased;
- Notable possession decreases following decriminalization; and

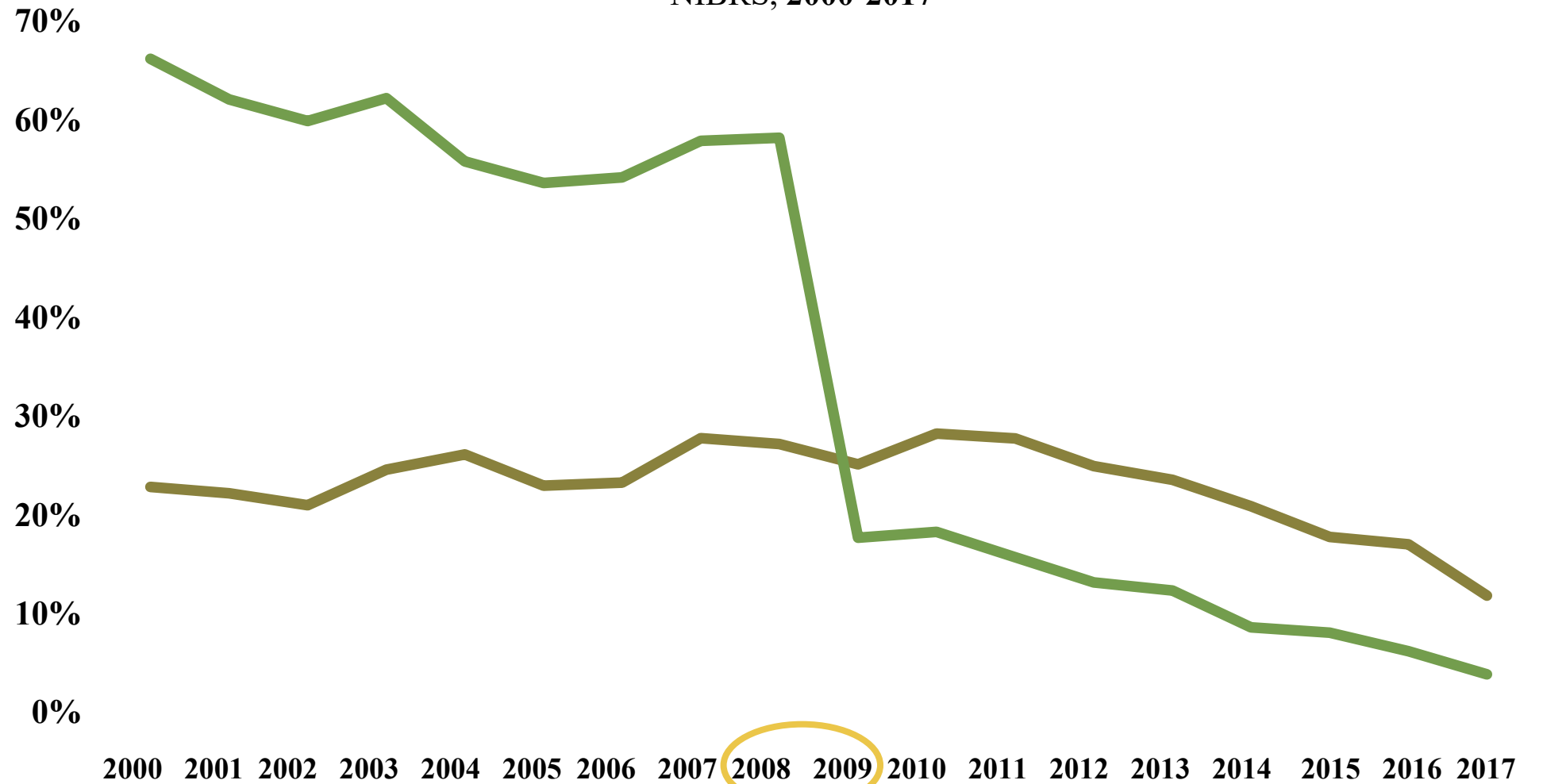

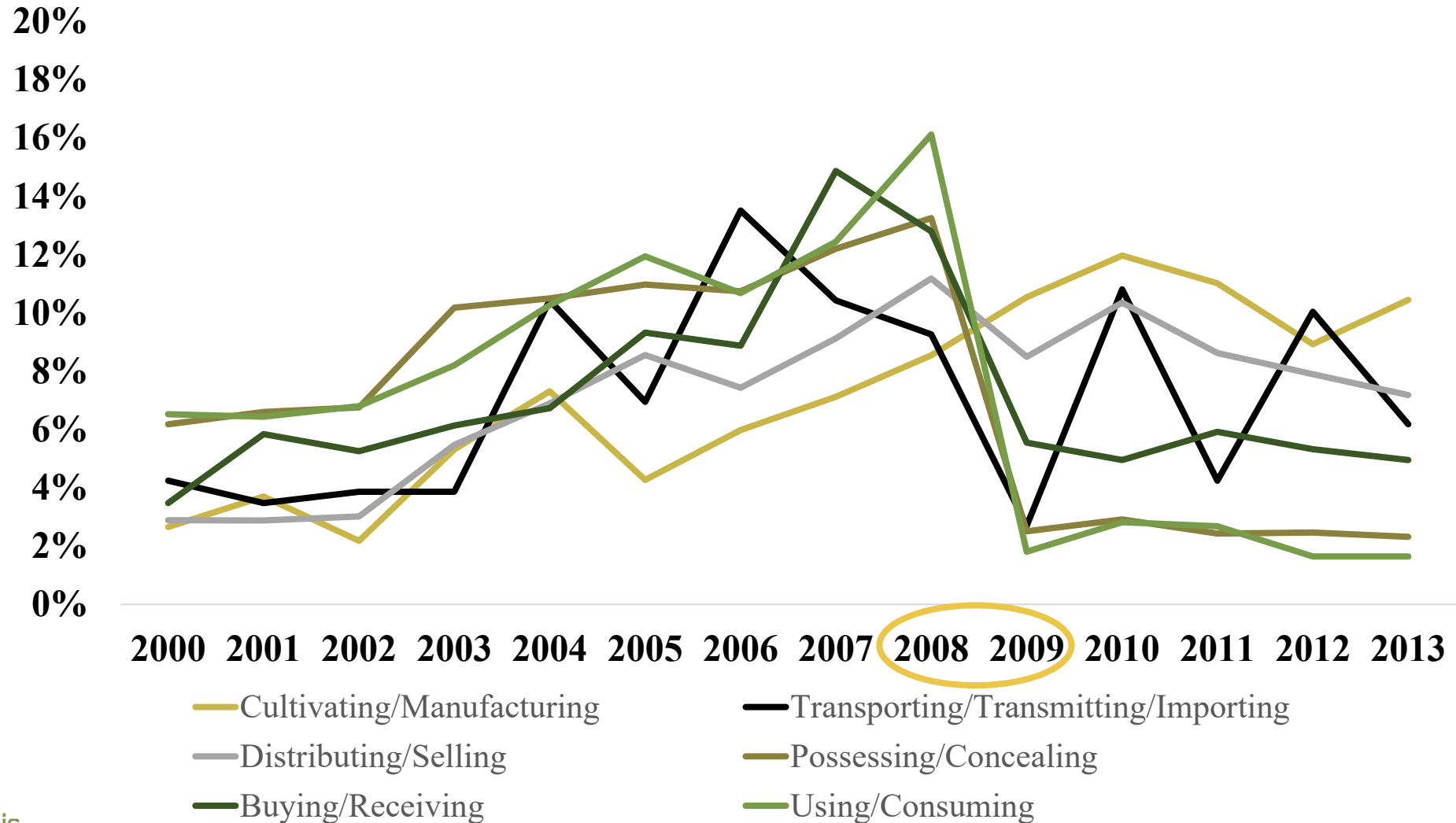

# What is the race/ethnicity breakdown of 94C cannabis violations? (“baseline”)

- Statewide, Blacks make up a larger share of most cannabis violations relative to their share of the population;
- Hispanics make up a larger share of transporting, distribution, possession, and buying/receiving violations relative to their population;
- Whites represent a smaller share relative to their population in all cannabis violations, except in cultivating/manufacturing and potentially in trafficking; and
- Asians represent a smaller share of all cannabis violations related to their share of the population, except potentially in trafficking.

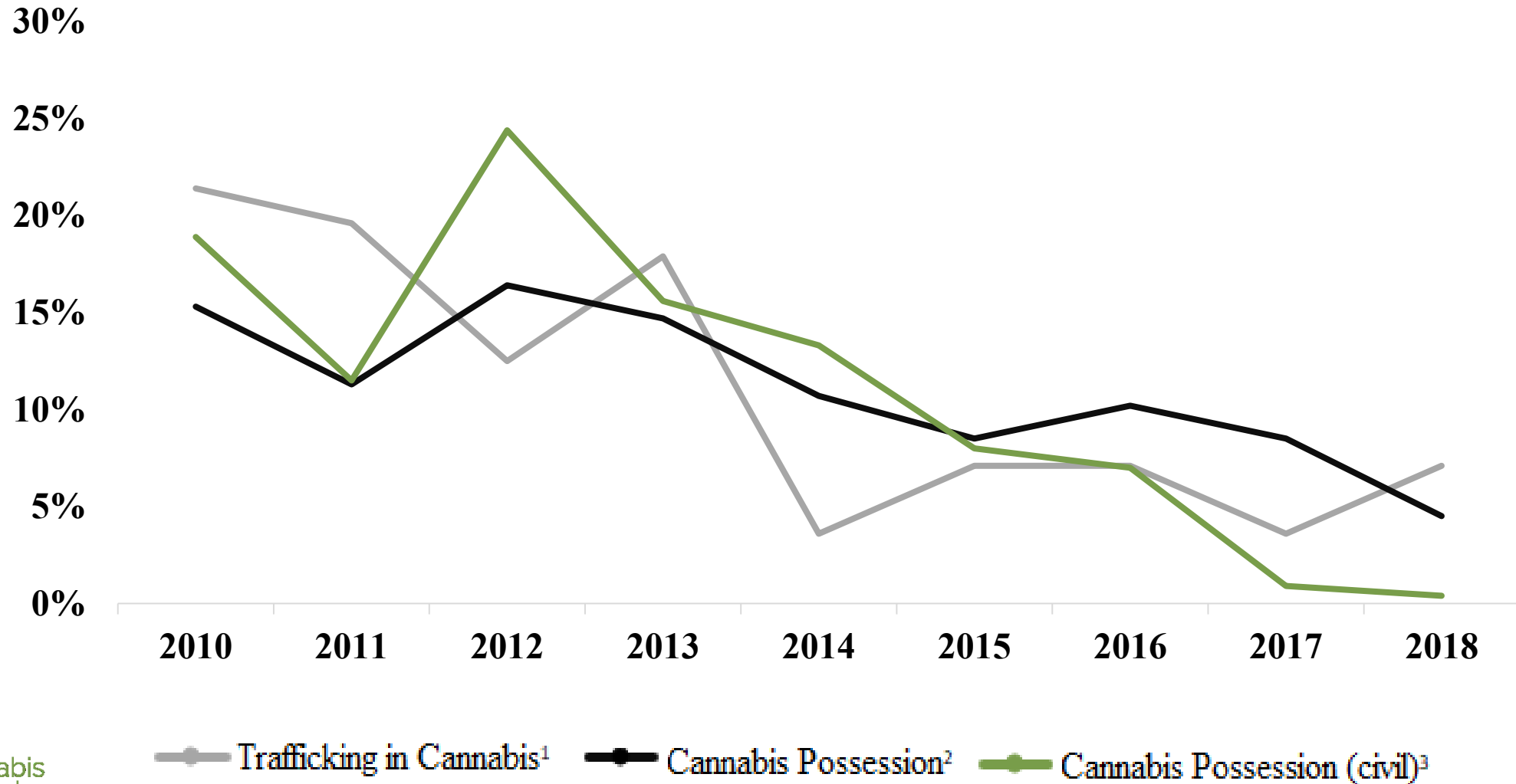

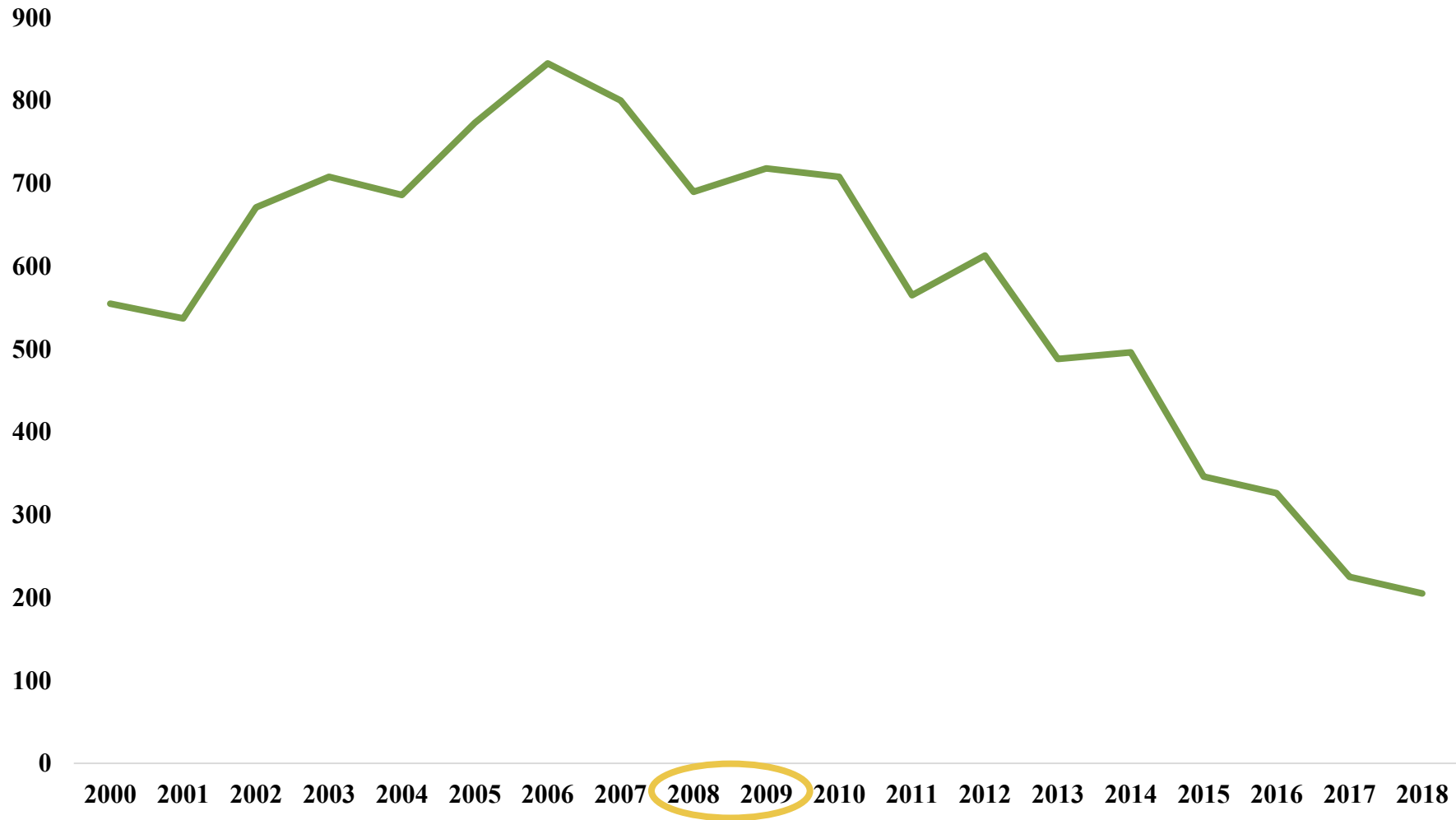

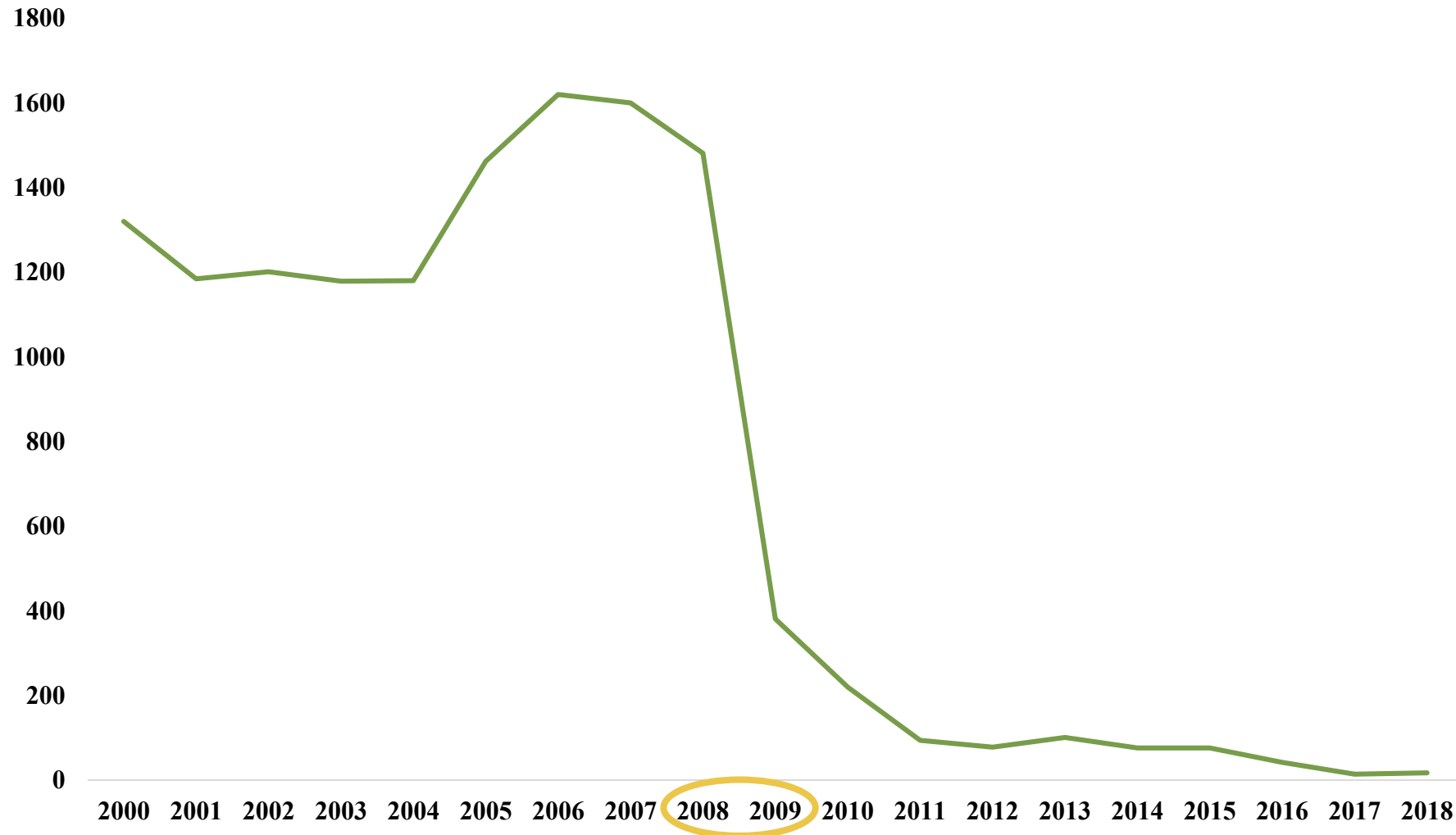

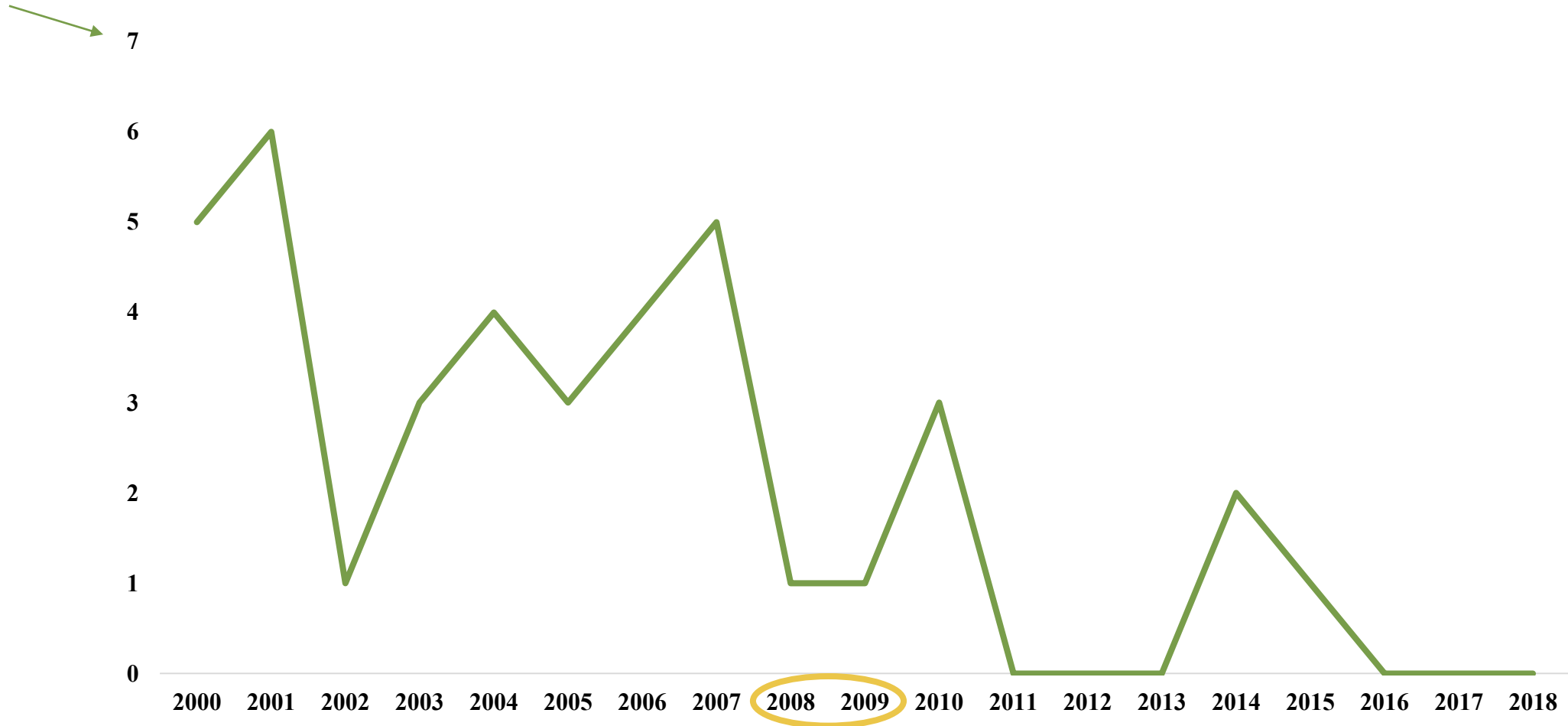
BPD Total M.G.L. c. 94C Cannabis and Class D **Possession** by Year (Frequency [%]), 2000-2018

BPD Total M.G.L. c. 94C Cannabis and Class D **Trafficking** by Year (Frequency [%]), 2000-2018

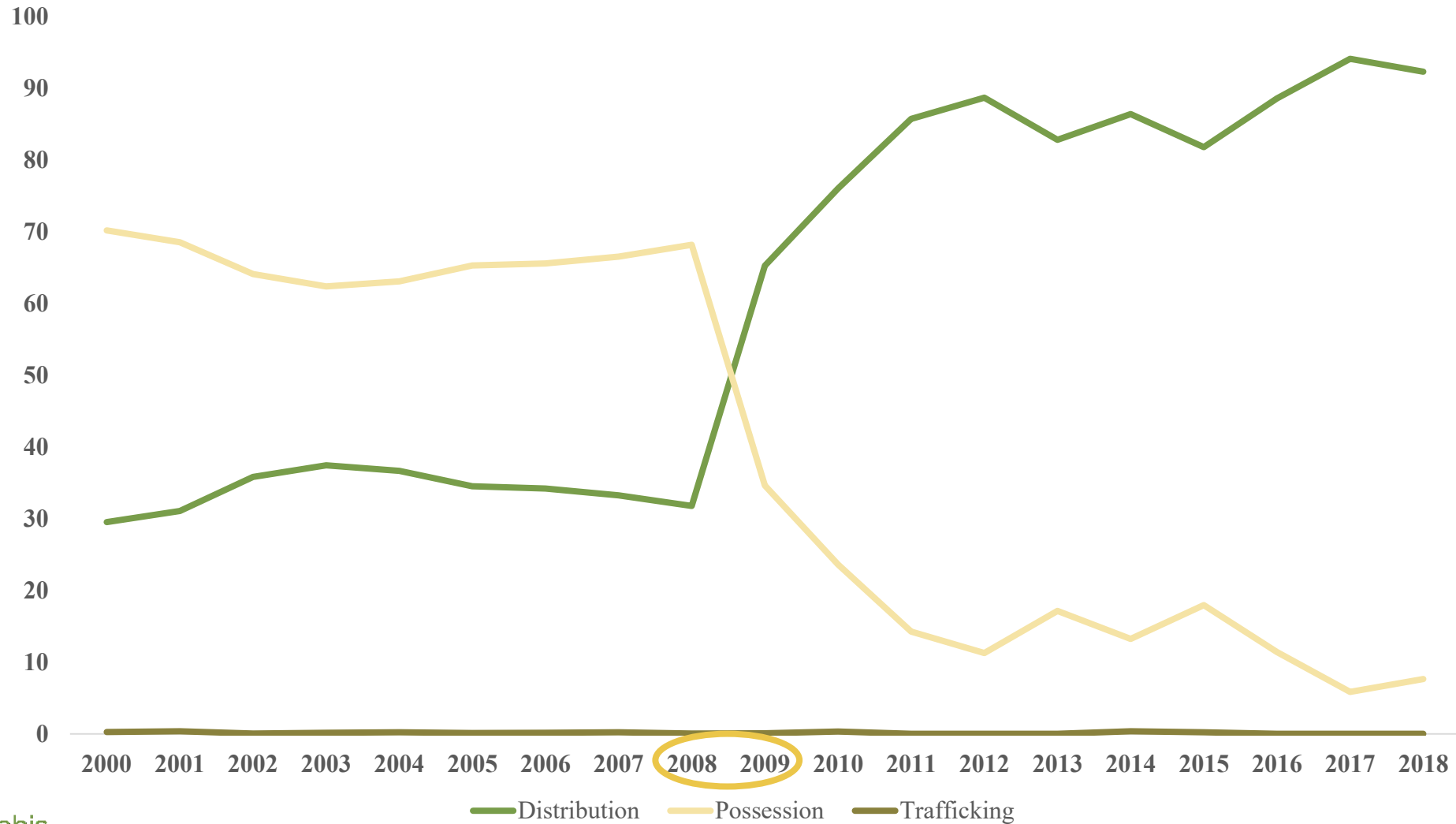

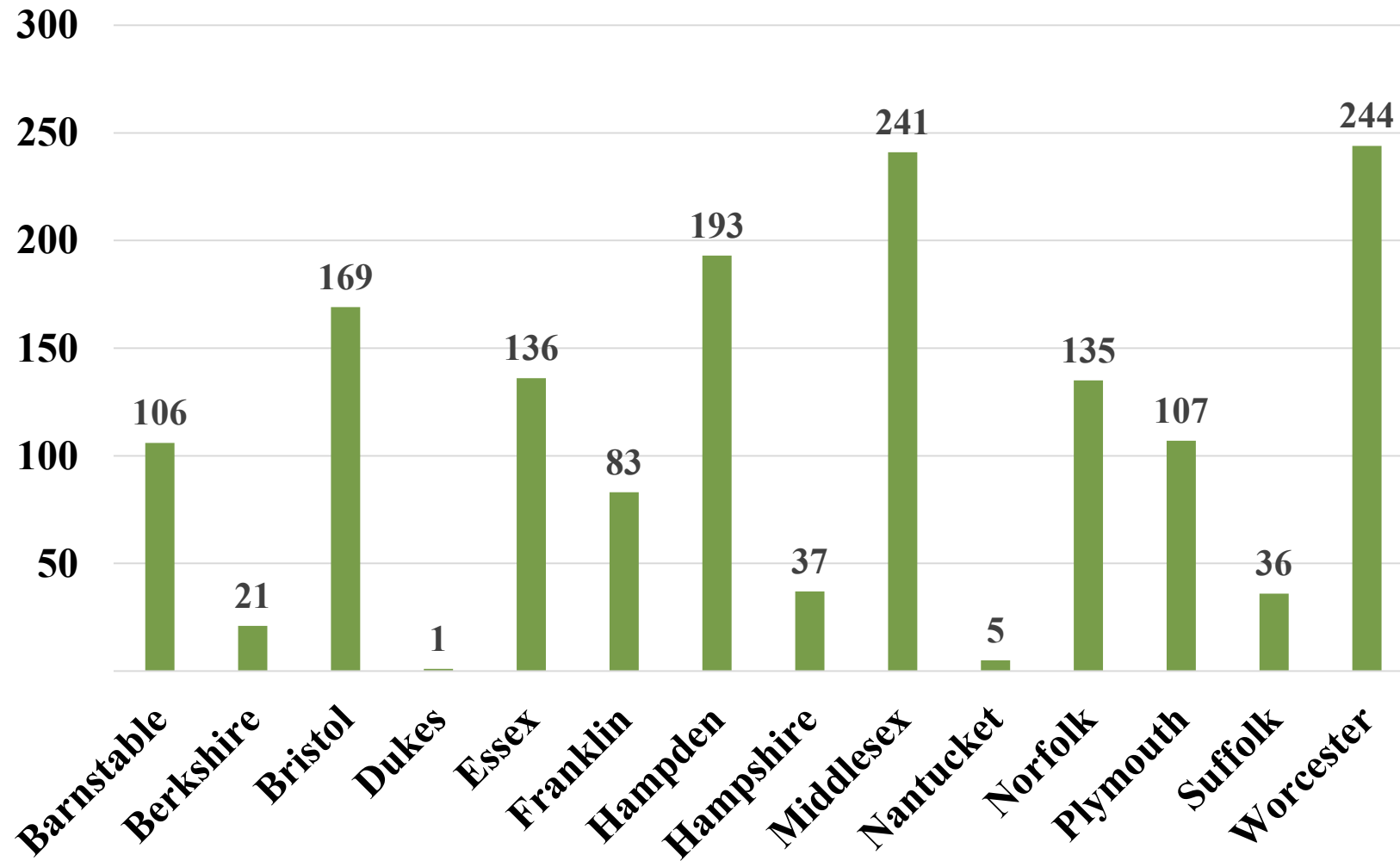

# Baseline Data: Economic Empowerment Applicant (EEA) Survey

- The Commission sent survey to all EEAs in July 2018 (Response Rate: 23%)



67% of EEAs who completed the application were satisfied with the application process

- Of EEA who did not apply:



— 47% reported difficulty raising funds or capital,



— 41% reported difficulty obtaining approval from a city or town,



— 40% reported that they are still developing a business concept/plan,



— 21% reported difficulty understanding the application,



— 20% reported that their desired license type is not offered (*e.g. social consumption/ delivery etc.*)

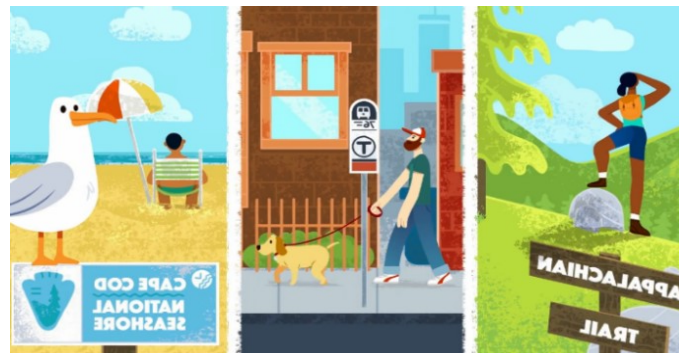
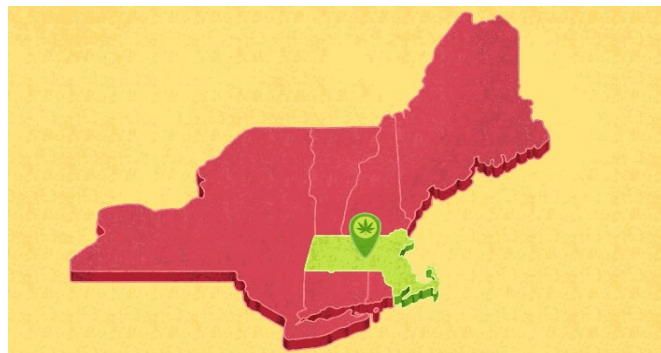

# Prevention – Focus Group Key Findings

- There was some confusion about whether the legal age to use cannabis was 18 or 21, and participants 40+ years were more likely to be confused
- Participants were aware possession and grow limits exist. Most were unsure of exact limits and wanted more information.
- Most participants understood that the law does not allow for public use, but some were unsure.
- Participants acknowledged not taking cannabis across state lines was “common sense,” but were concerned it may be easily and unknowingly violated.

# Research Gaps: Overview

- Massachusetts law enforcement data;
- Hispanic, Asian, and other non-Black/White samples in assessing impact of cannabis-related violations/enforcement;
- Mechanisms driving disproportionate impacts and the impacts of cannabis reform laws;
- Sealing and expungement research; and
- Impact of adult-use cannabis policies and social equity programs.

# Policy Considerations:

## *94C Violations and Public Safety*

**Consideration 1:** Consider formalizing data tracking mechanisms around cannabis-related M.G.L. c. 94C violations within and between law enforcement agencies;

**Consideration 2:** Consider necessary changes to court system data access or availability to support research efforts; and

**Consideration 3:** Consider ways to support municipality use of NIBRS, (*e.g. assessing barriers to use, education around accessing and interpreting relevant local data to make it useful to police chiefs*).

# Policy Considerations:

## *94C Violations and Impact [Social Equity]*

**Consideration 1:** All MA law enforcement agencies to track the race/ethnicity of all persons with cannabis-related M.G.L. c. 94C violation incidents;

**Consideration 2:** Consider formalizing law enforcement agencies to include collecting additional demographic information, such as country of origin; and

**Consideration 3:** Consider tracking M.G.L. c. 94C cannabis civil violations, including incidences, and demographics of persons found in violation (*e.g. age, gender, race/ethnicity*).



# Policy Considerations:

## *94C Violation Prevention*

**Consideration 1:** The Commission in collaboration with the Executive Office of Public Safety and Security (EOPSS) and varying relevant state agencies to continue public education via public awareness campaigns targeting MA constituents, including efforts to educate on: Laws and statutes of medicinal and non-medical adult-use cannabis laws that may intersect with M.G.L. c. 94C violations.
