- 7. The applicant and municipality executed a Host Community Agreement on May 15, 2018.
- 8. The applicant conducted a community outreach meeting on May 18, 2018 and provided documentation demonstrating compliance with Commission regulations.
- 9. The Commission received a municipal response from the municipality on May 13, 2019 stating the applicant was in compliance with all local ordinances and bylaws.
- 10. The applicant proposed the following programs for its Positive Impact Plan:
  - a. Institute hiring practices that will prioritize the hiring of individuals from disproportionate areas with a focus on Worcester;
  - b. Host and/or co-host at least two (2) job fairs annually in Worcester; and
  - c. Provide annual monetary and in-kind donations to Family and Community Resources, Inc.

### **SUITABILITY REVIEW**

- 11. There were no concerns arising from background checks on the individuals or entities associated with the application.
- 12. There were disclosures of past civil or criminal actions, occupational license issues, or marijuana-related business interests in other jurisdictions. None of the disclosures raised suitability issues.

- 13. The applicant states that it can be operational within ten (10) months of receiving its provisional license.

- 3. The applicant shall cooperate with and provide information to Commission staff;
- 4. Provisional licensure is subject to the payment of the appropriate license fee; and
- 5. Final licensure is subject to the applicant providing to Commission staff a revised Diversity Plan that specifies measurable goals.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
