The applicant received, and was reviewed as, an MTC Priority Applicant as they submitted their one of their applications prior to the Commission's policy clarification on October 10, 2019. However, under this policy, the applicant would still be classified as an MTC Priority Applicant as the adult-use licenses will be collocated with an MTC.

- 7. The applicant and municipality executed a Host Community Agreement on January 15, 2019.
- 8. The applicant conducted a community outreach meeting on December 23, 2019
- 9. and provided documentation demonstrating compliance with Commission regulations.
- 10. The Commission received a municipal response from the municipality on February 11, 2020 stating the applicant was in compliance with all local ordinances or bylaws.
- 11. The applicant proposed the following goals for its Positive Impact Plan:

1	Recruit 20% or more residents of Monson.
2	Contribute at least \$10,000 per year to at least two (2) local organizations in Monson.

SUITABILITY REVIEW

RECOMMENDATION

Commission staff recommend provisional licensure with the following conditions:

- 1. Final license is subject to inspection to ascertain compliance with Commission regulations;
- 2. Final license is subject to inspection to ascertain compliance with applicable state laws and local codes, ordinances, and bylaws;
- 3. The applicant shall cooperate with and provide information to Commission staff;
- 4. Provisional licensure is subject to the payment of the appropriate license fee;
- 5. Final licensure is subject to the applicant providing Commission staff, upon inspection, with an updated timeline as to when its MTC license with a dispensary in Easthampton will become operational; and
- 6. Final licensure is subject to the applicant providing Commission staff, upon inspection, a list of products referenced in their product plan and indicate in writing what they mean but pharmaceutical grade marijuana oil (i.e. potency) and where they intend to make it available.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
